NOTICE FOR REMOVING DISCREPANCIES IN ONLINE APPLICATION FORMS FOR THE POSTS OF STENOGRAPHER GRADE-III IN THE SUBORDINATE COURTS OF PUNJAB AGAINST ADVERTISEMENT NO. 20S/SSSC/PB/2017.
