PATTERN OF EXAMINATION: -

The written examination will consist of 50 objective type questions, most of which shall be relating to knowledge of Traffic Signs/Rules and Driving Skills and the rest of them on General Awareness and Aptitude. Each question will carry 1 mark. There will be no negative marking for wrong answer.

MODE OF SELECTION: -

The candidates who will secure 40% or more marks will be deemed to be qualified in the written examination and thereafter the number of qualified candidates as decided by the Hon'ble Central Recruitment Committee, High Court of Punjab and Haryana will be shortlisted for the Practical Driving Test and Interaction to be held later on. The final selection shall be based on the marks obtained by the candidates in the Practical Driving Test.
