5. Original Photo identity Proof.
6. Two passport size photographs one duly attested by the gazetted officer and other one unattested which was uploaded at the time of online submission of application.

IMPORTANT INSTRUCTIONS

The Purpose of calling for checking of testimonials/interaction is only to check/verify your claim to the particular category, qualification and age etc. Mere calling for checking of testimonials/viva-voce does not indicate that you have been selected. If any candidate fails to produce original certificates regarding qualification, age or category etc. on the date fixed, no further opportunity will be granted to him/her.
