3. Proof of Category (for Reserved Category Candidates).
4. In case of Govt. Employee-"**No Objection Certificate**" issued by the Employer.
5. Original and copy of Photo identity Proof.
6. Two passport size photographs one duly attested by the gazetted officer and other one unattested which was uploaded at the time of online submission of application.
