Candidates must bring following- documents in original, along with one set of attested copies of documents mentioned at sr. no. 1 to 6.

1. Proof of Graduation (Degree)/Detailed Marks Sheets (DMC).
2. Proof of Post-Graduation (Degree)/Detailed Marks Sheets (DMC), if any.
3. Proof of Date of Birth(Matriculation Certificate showing Date of Birth).
4. Proof of Category (for Reserved Category Candidates) and his/her ID's Proof.
5. In case of Govt. Employee-No objection certificate issued by the Employer.
6. Photo identity proof.
7. Two passport size photographs one duly attested by the gazetted officer and other one unattested which were uploaded at the time of online submission of Application.

IMPORTANT INSTRUCTIONS:-

The purpose of calling for checking of testimonials is only to check/verify claim of a candidate to the particular category, Qualification and age etc. Mere calling for checking of testimonials/interaction does not mean that he/she has been selected, it is only for administrative purpose. If any candidate fails to produce original certificates regarding qualification, age, category or NOC etc. on the date fixed, no further opportunity will be granted to him/her and candidate next in merit will be considered for checking of testimonials/Certificates.
