1. It is clarified that the final merit is based solely on the marks obtained in Practical Driving Test.
2. Candidate with Registration ID 70175514 did not produce Residence Certificate of Punjab, as such his candidature is treated in General Category.

Since, he had scored less marks in written examination than the last candidate of General Category shortlisted for Practical Driving Test, as such, he is not considered in the final merit list.

3. Candidature of Candidates with Registration IDs 70142454, 70179186, 70176531 and 70178913 stands rejected as they do not possess the requisite qualification/requirement as prescribed in The Punjab Subordinate Courts Establishment (Recruitment and General Conditions of Services) Rules 1997 duly mentioned in the advertisement for the said post.
